Therefore Be It Resolved that the Royal Canadian Legion's Defence and Security Committee, as a government stakeholder, immediately advocate through the Chancellery of Honours, for new Honours and Awards for military personnel and Veterans including a Combat Action Medal/Decoration, and a Domestic Operations Medal (or Bar to the Special Service Medal) for accumulated service on Domestic Operations of 30 days or more, both awards to be retroactive to 1990.

Whereas over 2000 Canadians have signed Parliament of Canada E-Petition 1418 in support of the reinstatement of the Canadian Volunteer Service Medal;

Therefore Be It Resolved that the Royal Canadian Legion's Defence and Security Committee, as a government stakeholder, immediately advocate through the Chancellery of Honours their support of the Canadian Volunteer Service Medal's reinstatement and issue.

Whereas the Royal Canadian Legion as a Veterans organization should keep closely to the military standard for wearing medals and insignia;

Whereas the Royal Canadian Legion comes under constant scrutiny for the wearing of medals that are not part of the Canadian Honours & Awards System;

Whereas the Order of Saint John was brought into the Canadian Honours & Awards System in 1990 and its medals, The Order of St. John of Jerusalem and The Service Medal of the Most Venerable Order of St. John of Jerusalem, are part of the Honours and Awards System and are worn on the left breast in precedence, medals are administered through their offices;

Whereas the Royal Canadian Legion can bring credibility to itself by reducing the right breast medals and replacing them with awards in the Canadian Honours and Awards System;

Whereas in the Canadian Honours and Awards system is the Sovereigns Medal for Volunteers which members of the Legion can nominate other members of the Legion for volunteer service at any level; Whereas the Royal Canadian Legion must earn back the trust and respect of ALL of Canada's Veterans; Whereas this was identified by participants in the Veterans and the Royal Canadian Legion Survey as an issue and recommended in the Veterans and the Royal Canadian Legion Survey Report launched by Branch 15 Brampton in 2016;

Therefore Be It Resolved that the Royal Canadian Legions Defence and Security Committee, as a stakeholder, immediately seek to create through the Chancellery of Honours new Canadian Honours and Awards: a Royal Canadian Legion Medal of Merit (to replace the right breast RCL Medal of Merit) and a Royal Canadian Legion Service Medal (to replace the right breast Branch Service Medal), and a Royal Canadian Legion Dominion President Commendation (similar to the Minister of Veterans Affairs Commendation);

Therefore Be It Further Resolved that upon successful completion and implementation of the above Honours and Awards, the Constitution and By-Laws of the Royal Canadian Legion be amended immediately to remove the current (right breast medals) Legion Medals, except for Executive Officer Medals and the Cadet Medal of Excellence, from authorized wear.
